Welcome to Moldova! Register your stay in our country!

According to the legislation of the Republic of Moldova, foreigners who enter the Republic of Moldova from Ukraine through the Moldovan-Ukrainian State border segment not controlled by the Moldovan authorities – the Transnistrian segment, are obliged to register their stay with the competent authorities of the Republic of Moldova within 72 hours of crossing the Moldovan-Ukrainian border.

Who must register? Foreigners who entered the Republic of Moldova through the Moldovan-Ukrainian State border segment not controlled by the Moldovan authorities must register. This particularly applies to foreigners who entered the Republic of Moldova from Ukraine through the Transnistrian segment of the border.

This requirement does not apply to foreigners who entered the Republic of Moldova through the State border controlled by the Moldovan authorities, to citizens of the Republic of Moldova, or to foreigners who are staying in the



epublic of Moldova on the basis of a residence ermit issued by the competent authorities of the apublic of Moldova.



Where can you register? Registration can be done at any of the regional or territorial offices of the Bureau for Migration and Asylum or at the territorial subdivisions of the Centre for State Information Resources "REGISTRU". A list and contact details of these offices can be found on the back of this leaflet.

What is the time limit for registration?

Foreignersmustregisterwithin72hoursofcrossing the Moldovan-Ukrainian State border through the crossing points not controlled by the Moldovan authorities.

What documents are necessary for registration? Foreigners must present their travel document (e.g. a passport) based on which

they were allowed to enter the Republic of Moldova. The document must be valid for at least 3 months upon the date of entry.

What are the registration costs?

Registration is free of charge.

What documents confirm the registration?

Foreigners who register receive a registration slip confirming the time and date of their registration. This must be kept with them until they leave the territory of the Republic of Moldova.

What are the consequences of non-registration? The period of legal stay for foreigners on the territory of the Republic of Moldova is calculated according to the registration data. This will either be the period of visa validity or 90 days for citizens of States that have no visa regime with the Republic of Moldova. Non-registration and/or violation of the period of stay in the Republic of Moldova are sanctioned administratively by a fine, according to Articles 333 and 334 of the Contravention Code.
